## APPLICATION FOR PARKING PERMIT & REGISTRATION

**IMPORTANT** - Notification is not required to park a boat, trailer, camper, or motor home on a resident's driveway if the time period is less than 24 hours.

**For periods greater than 24 hours:**

1. For periods greater than 24 hours AND up to Seven (7) days, Members are required [by Article VI "Use Restrictions (e) "Parking Restrictions"] to Register with the Association and receive a Conditional Use Parking Permit.
  - a. Members complete the application identifying the type of vehicle and check Box "B" for the Registration & Permit Period.
  - b. A director signature is required for approval with notification to other Board members.
2. For periods **greater than Seven (7) days**, Residents may request special consideration for relief from the Seven (7) days clause.
  - a. Members complete the Parking Permit & Registration.
  - b. Member provides details of extenuating circumstances supporting the need to exceed the requirements defined in the Reinstatement of Covenants and Restrictions, Article VI "Use Restrictions (e) "Parking Restrictions"
3. Board Review
  - a. Based on reasonable consideration of the Member's need, the extended use application may be recommended for approval by the reviewing Board member and presented to the remaining Board members.

The President, with discretion from By-Laws Article XII "Standards", (2) "Preservation" has authority to approve the application.
